In terms of Regulation 30 of SEBI (Listing Obligations and Disclosures Requirements) Regulations, 2015 ('SEBI LODR Regulations'), we hereby wish to inform you that a First Information Report bearing no. 506 of 2024 has been registered at the Sinnar MIDC Police Station against Mr. Girish Siriram Juneja, Resolution Professional to Hindusthan National Glass & Industries Limited & Mr. Ramchandra Parasam Une, Plant Head of Sinnar Plant on 21.10.2024.

Mr. Girish Siriram Juneja & Mr. Ramchandra Parasam Une had applied for and obtained ad-interim anticipatory bail in Criminal Bail Application No. 2224/2024, Police Station – Sinnar MIDC Police Station in the Court of District Judge – 7 and Additional Sessions Judge, Nashik in terms of an order dated 23.10.2024, which, since, stood extended on 6.11.2024.

In our opinion, registration of an FIR does not warrant for a disclosure under Regulation 30 of SEBI LODR Regulations, as the same neither constitutes 'litigation' nor does it have an impact on the listed entity. However, the disclosure is being made in order to ensure good corporate governance.
